

## GARDEN VALLEY RECREATION DISTRICT/WEILMUNSTER PARK

### RULES, REGULATIONS AND PARK RENTAL INFORMATION

EFFECTIVE JANUARY 1, 2023

Weilmunster Park is open to the public from Sunrise to Sunset.

Persons or Groups with Reserved Use of Weilmunster Park may not prevent public use of the Veteran's memorial, walking path, basketball court, volleyball court or river access. Reserved use of the Pavilion and/or park allows the public to visit the Veteran's Memorial and other areas of Weilmunster Park during any and all reserved events.

Cleanliness is the responsibility of all park users. Weilmunster Park has a "Pack it in – Pack it out" policy. All groups are responsible for proper disposal of all trash. **If any debris is left or there is damage to the park or restrooms, the return of the security/cleaning deposit will be reduced accordingly.**

BBQ's, portable gas grills, heat generating equipment or materials shall not be placed on any concrete surface, near any tree trunks or under the branches of any tree. BBQ equipment must be self-contained. Confetti, bird seed, straw, popcorn, rice, and the like are prohibited. No decorations allowed in the Veteran's Memorial area.

A fee is required to secure rental of Weilmunster Park Pavilion/Weilmunster Park Facility (21 acres). Weilmunster Park Permit/Contracts are available through the website at [www.gvrecdistrict.org](http://www.gvrecdistrict.org) or by email at [park@gvrecdistrict.org](mailto:park@gvrecdistrict.org). Weilmunster Park is not a city park.

Payment of cleaning and security deposit and a signed Weilmunster Park Permit/Contract must be received seven (7) days after initial request or your reservation request or the reservation request will be secondary to subsequent paid reservations. A \$25 non-refundable processing fee will be charged for any reservation that is cancelled fourteen (14) or more days prior to event date. Reservation monies will not be returned if event is cancelled less than fourteen (14) days prior to the event. Refunds or rescheduling are not granted by the Garden Valley Recreation District due to adverse weather conditions or acts of nature.

#### **NON-PROFIT USE:**

Reservation by a local non-profit may be granted without rental fee. Application must be completed and presented for approval to the Garden Valley Recreation District Board.

**ALCOHOL/CATERING AND FOOD SUPPLIERS FOR EVENTS:**

Alcoholic beverages other than beer and wine are not permitted in Weilmunster Park. Beer and wine may be possessed or consumed within Weilmunster Park except upon any street, parking lot, restroom, pathway, or the Veteran's Memorial Area. Distribution or sale of beer and wine within Weilmunster Park is allowed only as local and state laws and regulations allow. Caterers and/or vendors serving beer or wine must provide proof of liability insurance to GV Rec District.

All public events at Weilmunster Park including food/food service require Idaho Central District Health food handling permits for all caterers, vendors, and servers. The permit is required for any event where food is being sold or supplied to the public. This permit is available at [www.cdhd.idaho.gov](http://www.cdhd.idaho.gov).

**SALES:**

The Greater Garden Valley Chamber of Commerce offers a low-fee vendor membership for businesses that participate in four (4) or fewer events in Garden Valley per year. Garden Valley Recreation District encourages all vendors to become members in the Greater Garden Valley Chamber of Commerce. [www.gvchamber.org](http://www.gvchamber.org)

**POWER/WATER:**

110-volt electrical power is available with a reservation at Weilmunster Park Pavilion. Only one appliance per outlet. There are six outlets available for use at Weilmunster Park along the fence near the Pavilion. **Groups overloading circuits resulting in an on-site visit to reset circuits will be charged a \$75 fee.**

Weilmunster Park water spigots are strictly non-potable and are intended for irrigation and maintenance crew purposes only. Park users are prohibited from depositing their ice and any grey or wastewater on the grass, sidewalks, waste receptacles, dumpsters, planters, or parking lot. All water amenities must have prior approval from the Board of the Garden Valley Recreation District – e.g. dunk tanks, water slides, kiddie pools, commercial misters etc.

**PARKING:**

Parking is limited to designated areas and available on a first-come, first-served basis. Vehicles parked in Handicapped Areas without proper authorization, vehicles parked in No Parking areas or vehicles left in the park after hours will be towed at owners' risk and expense. Due to turf and sprinkler head damage, vehicles are restricted to paved park roads or parking areas. This includes concession trailers, delivery, and catering vehicles. **NO VEHICLES ARE ALLOWED ON THE GROUNDS OF WEILMUNSTER PARK OUTSIDE OF THE PARKING AREA WITHOUT PRIOR RESERVATION APPROVAL BY THE GARDEN VALLEY RECREATION DISTRICT.**

**SOUND AMPLIFICATION and NOISE ORDINANCE:**

Weilmunster Park prohibits sound amplification after 8pm from the Saturday of Memorial Day in May until the Saturday of Labor Day in September. This is in partnership with the Starlight Mountain Theater adjacent to Weilmunster Park. Sound amplification after 8pm may be acceptable with a reservation outside of these dates or mid-week but will require the approval of the Garden Valley Recreation District.

**PICNIC TABLES:**

Picnic tables in the Pavilion may be re-arranged but not be removed from the Pavilion area to other parts of Weilmunster Park. **Picnic tables within the Pavilion must be returned to their original location or security deposit will be forfeited.**

**VETERAN'S MEMORIAL:**

No equipment, tables, decorations, signs, or other items may be placed at or within the Veteran's Memorial area. Please respect this area. Visitors to the Veteran's Memorial are welcome from dawn to dusk and cannot be prevented from accessing this area during reserved events.

**PETS:**

Dog owners are required to clean up after their pets. Pet waste stations are available onsite. Pets are not allowed to harass, stalk or chase waterfowl or other animals. Please leash your pet if necessary. All injuries or damage will be the responsibility of the pet owner. Garden Valley Recreation District and its board of Directors, Employees and Volunteers will not be held liable for damages incurred by any animal upon the property of the Garden Valley Recreation District.

**WILDLIFE AND LIVESTOCK:**

Please refrain from disturbing or feeding wildlife. Loose livestock are strictly prohibited within Weilmunster Park. Any and all damage to Weilmunster Park resulting from loose livestock or any other animal will be the responsibility of the owner.

**TREES:**

It is unlawful for any person to cut, injure, deface, or damage any tree on park property. No signs or related hardware (ropes, wires, nails, decorations, notices, posters etc.) are to be attached to any tree. Animals or bicycles shall not be attached or tied/locked to trees. No chemicals, cleaners, pesticides, or other liquids are to be deposited near trees.

**FIREARMS, FIRES, FIREWORKS:**

Discharge of any firearm, pellet gun, or air gun within Weilmunster Park is prohibited.

No persons shall be permitted to have any fires to be set or used upon any Garden Valley Recreation District Property. If approved fire pits are provided by the Recreation District or previously permitted through the reservation process with the GVRD, you may build a small campfire in those approved fire pits. Fire pits must be "cold out" prior to departure. If there are Fire Restrictions in effect, all fires may be prohibited. It is your responsibility to understand current Fire Restrictions on the date of your event. FIREWORKS PROHIBITED at Weilmunster Park with the single exception: Crouch Annual Professional Fireworks.

**CANOPIES/TENTS/KIOSKS:**

All canopies will be weighted (NO STAKES ALLOWED) to avoid damage to electrical, irrigation and water lines. Kiosks and structures must be light duty and all extension cords and power strips are the responsibility of the vendor/renter. There are 6 outlets available for vendor use at Weilmunster Park along the fence near the Pavilion. Damage resulting from the use of stakes will be the responsibility of the renter for all costs incurred to repair.

CAMPING IS PROHIBITED AT WEILMUNSTER PARK without prior permit approval through the Garden Valley Recreation District.

**MISSION:**

Enhancing the quality of life for district residents by working in partnership to foster and enrich healthy community environments, protect recreational access, and promote activities.

The Garden Valley Recreation Taxing District was formed in May 2000. The Board of Directors is an elected, policy setting body with legal authority as provided by Idaho Code. They are primarily responsible for the overall direction and management of the district and any personnel and services that are delivered by the district. The Garden Valley Recreation District was also formed in May 2000 according to the procedures outlined in the Idaho Code.
