

**GARDEN VALLEY RECREATIONAL DISTRICT
RESOLUTION NO. 2023-02**

A RESOLUTION RECINDING AND REPLACING RESOLUTION NO. 2021-04 AND DECLARING, PREPARING, APPROVING, AND ADOPTING THE DIRECTOR'S SUBDISTRICT BOUNDARIES OF THE GARDEN VALLEY RECREATIONAL DISTRICT, BOISE COUNTY, IDAHO.

WHEREAS, the Board of Directors of the Garden Valley Recreational District desire to be in conformity with Recreation and Election Laws per Idaho Code; and

WHEREAS, the Board of Directors of the Garden Valley Recreational District desires to divide the district into subdivisions as nearly equal in population as possible; and

WHEREAS, the Board of Directors of the Garden Valley Recreational District desires to divide the district into subdivisions as practical as possible; and

NOW, THEREFORE BE IT RESOLVED that the Board of Directors of the Garden Valley Recreational District, Boise County, Idaho, in compliance with the requirements of Idaho Code, the Garden Valley Recreational District does hereby adopt as the legal descriptions of the subdistrict boundaries therein designated as director's subdistrict 1,2,3,4, and 5 to wit:

Director's Subdistrict No. 1

Beginning at the Northwest corner of Section 9, T.9 N., R.4 E. Boise Meridian;
Thence East 3 miles more or less along section and correction lines to the Northeast corner of Section 11, T.9 N., R.4 E.;
Thence South 2 miles more or less to the Southeast corner of Section 14, T.9 N., R.4 E.;
Thence West 2 miles more or less to Southwest corner of Section 15, T.9 N., R.4 E.;
Thence North 1 miles more or less to Southwest corner of Section 10, T.9 N., R.4 E.;
Thence West 1 mile more or less to the Southwest corner of Section 9, T.9 N., R.4 E.;
Thence North 1 miles more or less along the west line of Section 9, T.9 N., R.4 E. to the real Point of Beginning.

Director's Subdistrict No. 2

Beginning at the Northwest corner of Section 9, T.9 N., R.4 E. Boise Meridian;
Thence West 6 miles more or less along section and correction lines to the center of the channel of the North Fork of the Payette River;
Thence South 2 miles more or less along said channel of the North Fork of the Payette River to the South section line of Section 16, T.9 N., R.3 E.;
Thence East 3 miles more or less along section lines to the Southeast corner of Section 13, T.9 N., R.3 E.;
Thence South 9 miles more or less to the Southwest corner of Section 31, T.8 N., R.4 E.;
Thence East 3 miles more or less to the Southeast corner of Section 33, T.8 N., R.4 E.;
Thence North 10 miles more or less along the section and correction lines to the Southwest corner of Section 10, T.9 N., R.4 E.;
Thence West 1 mile more or less to the Southwest corner of Section 9, T.9 N., R.4 E.;
Thence North 1 mile more or less along the west line of Section 9, T.9 N., R.4 E. to the real Point of Beginning.

Director's Subdistrict No. 3

Beginning at the intersection of the channel of the North Fork of the Payette River and the intersection of the Boise-Valley County Line;

Thence East 10 miles more or less along the Boise-Valley County line to the intersection of the centerline of the Middle Fork Road;

Thence southerly 7 miles more or less along said centerline of the Middle Fork Road to the North section line Section 10, T.9N., R.4E.;

Thence West 7 miles more or less along section and correction lines to the channel of the North Fork of the Payette River;

Thence North 7 miles more or less along the said channel of the North Fork of the Payette River to the Point of Beginning.

Director's Subdistrict No. 4

Beginning at the intersection of the Centerline of the Middle Fork Road with the Boise-Valley County Line;

Thence East 11 miles more or less along the Boise-Valley County Line to the Northeast corner of Section 1, T.10 N., R.6 E., Boise Meridian;

Thence South 7 miles more or less along township lines to the Southeast corner of Section 1, T.9 N., R.6 E.;

Thence West 15 miles more or less along section and corrections lines to the intersection of the Centerline of the Middle Fork Road;

Thence generally northerly 7 miles more or less along the centerline of the Middle Fork Road to the Point of Beginning.

Director's Subdistrict No. 5

Beginning at the Southeast corner of Section 1, T.9N., R.6E., Boise Meridian;

Thence South 5 miles more or less along township lines to the Southeast corner of Section 36, T.9N., R6E.;

Thence West 6 miles more or less along the section lines to the Southwest corner of Section 31, T.9N., R.6E.;

Thence South 2 miles more or less along township line to the Southeast corner of Section 12, T.8N., R5E.;

Thence West 5 miles more or less along section lines to the Southeast corner of Section 7, T.8N., R5E.;

Thence South 3 miles more or less along section lines to Southeast corner of Section 30, T.8N., R5E.;

Thence West 3 miles more or less along section lines to Northwest corner of Section 35, T.8N., R.4E.;

Thence South 1 mile more or less to the Southeast corner of Section 34, T.8N., R.4E.;

Thence West 1 mile more or less to the Southwest corner of Section 34, T.8N., R.4E.;

Thence North 9 miles more or less along section and correction lines to the Southwest corner of Section 15, T.9N., R.4E.;


Thence East 2 miles more or less to the Southeast corner of Section 14, T.9N., R.4E.;

Thence North 2 miles more or less to the Northeast corner of Section 11, T.9N., R.4E.;


Thence East 13 miles more or less along section and correction lines to the Point of Beginning.
